The #1 question I get asked the most is "I have a heart to serve and/or minister; therefore, should I be a non-profit?"

Difference between Non-Profit and For-Profit is source of income

Non-Profit funding from donation, grants, and government

Requires Board of Directors who has the fiduciary responsibility to oversee and manage the non-profit

Lots of IRS Compliance Requirement

Restrictions on the amount of Salaries that can be paid and to whom

Must Pass Public Support Test

#### Partnership: Pros vs. Cons

#### Pros:

- Flexible Profit Allocations
- No Tax on the Business
- No limit on who can be in a Partnership

#### Cons:

- Federal & State Taxed on net income even if you do not distribute any income, on personal tax return
- 15.3% Self Employment Tax on each partner & on total net income
- Partners not considered employees of the business, thus no business tax deduction on salaries or payroll taxes

#### S-Corporation: Pros vs. Cons

#### Pros:

- 15.3% Employment Tax only applies to Salaries Paid and NOT net income
  - 15.3% Employment Tax, split 7.65% to owner & 7.65% to S-Corp business
- No Federal or State Tax on the Business
- Owner's Salaries and Employment Tax are tax deductible business expense
- No Capital Gains Tax on Distributions

#### Cons:

- Restrictions on who can be owners
- Profit Allocations MUST be equally for each owner
- MUST pay a Reasonable Salary to active owners
- Federal & State Taxed on net income even if you do not distribute any income, on personal tax return

#### C-Corporation: Pros vs. Cons

#### Anyone can be an owner, no restrictions

- Best for raising outside capital or for Going Public
- 15.3% Employment Tax only applies to Salaries Paid and NOT net income
  - 15.3% Employment Tax, split 7.65% to owner & 7.65% to S-Corp business
- Owner's Salaries and Employment Tax are tax deductible business expense

#### Cons:

- Flexible Profit Allocations
- MUST pay a Reasonable Salary to active owners
- Capital Gains Tax on Distributions



#### Tax Strategies

- Augusta Rule combined with Home Office Deduction
- Hire your Child/Build Wealth
- 401K/Retirement Accounts



#### Augusta Rule with the Home Office Deduction

- Rent out your personal, dwelling to your business for business purposes for up to 14 days (doesn't have to be consecutive days)
  - Annual Meetings, Team Building, Seminars, Retreats, etc.
  - Tax FREE to you! And Tax Deductible for your business
  - Create rental agreement, you send a bill to your company for payment, document who attend, topics discussed, the area of the home used for event

#### Home Office Deduction

- Use a different area of your home
  - Area MUST be exclusive & regularly used for business
  - Deduct: property taxes, utilities, general repairs (painting), insurance, pest control, cleaning services, HOA fees, garbage fee

#### Augusta Rule with the Home Office Deduction

#### Home Office Deduction

- Use a different area of your home than used for Augusta Rule
  - Area MUST be exclusive & regularly used for business
  - Deduct: property taxes, utilities, general repairs (painting), insurance, pest control, cleaning services, HOA fees, garbage fee, depreciation (subject to recapture, when you sell your home)
  - Create an Accountable Plan that says you can be reimbursed by the business for home office
  - Submit expense report to your business
  - In your Operating Agreement state that owners are allowed to have a home office

#### Hire Your Children

#### Wealth Building Strategy

- Hire your child for an age-appropriate job at a skill appropriate pay
  - Document detailed job description and work hours
  - Track/Document hours worked (recommend using time track software/app)
  - Your business gets the tax deduction, Your child build wealth!
    - Child can earn up to \$14,600 per year and NO Federal Taxes!
    - Recommend: direct deposit some into ROTH retirement account that will compound grow into wealth!

#### Retirement Building

What if the Lord have you to start this business to build for Long Term?

- Maximum contribution in 2024 is \$64,000 under 50 & \$76,500 over
   50
- Contributions can be pre-tax or after tax
- Tax deductible for business, build more wealth for you!


